Indian Navy invites applications for the posts of Boat Crew Staff classified as Group 'C', Non-Gazetted, Non-Industrial from eligible candidates to apply online through Indian Navy website www.joinindiannavy.gov.in for the posts of Syring of Lascars, Lascari-I, Fireman & Topass. Selected candidates normally will have to serve in the units under administrative control of Headquarters, Western Naval Command, Mumbai. They can however be posted anywhere or both, at Naval units formations as per administrative requirement. The vacancy details are as follows:-

Physical requirement suitability for PreBCs - As per posts identified by Ministry of Social Justice & Empowerment notification No. 36-15-2023-DD-II dated 04 Jan 2024 amended vide notification No. 30-12/2020-DD-II dated 24 Aug 2022, the PreBC candidates belonging to following suitable categories of benchmark disability may apply for above posts accordingly:-

Persons with SC/ST with associated limb dysfunction shall be covered under the respective sub category such as DL, OA etc. as the case may be.

Note:- PreBC candidates must be in possession of disability certificate issued by the Competent Authority prior to applying Online, in the prescribed format as mentioned at Rule 10(1) of Ministry of Social Justice and Empowerment Notification G.S.R 501(E) dated 15 Jun 2017. Reservation. Reservation for SC/ST/OBC/EWS categories are available as per Government Orders. The reserved vacancies will be filled up separately from amongst the eligible SCs, STs, OBCs, EWS candidates which will thus comprise of SC, ST, OBC, EWS who are either lower in merit than the last candidate on merit list of UR, OBC, EWS who are either lower in merit than the last candidate on merit list of SC category or SC/ST/OBC candidates who have availed age relaxation for the respective category irrespective of their position in merit list. Similarly, reserved vacancies for PreBCs, ESM & Ex-Agriseers will be filled up from amongst such eligible candidates who are lower in merit than the last candidate on merit list of respective category but otherwise found suitable for the appointment even

if relaxed conditions. Reservations for PreBCs, ESM & Ex-Agriseers fall under the category of horizontal reservation which cuts across vertical reservation i.e. reservation for SC/ST/OBC-EWS (what is called into-casting reservation).

The candidates selected against the PreBCs, ESM & Ex-Agriseers quota will be placed in the appropriate category of UR/SC/ST/OBC/EWS as the case may be.

4. Essential Qualification

Note: (a) Syring certificate granted under Inland Vessels Act, 2021 will also be accepted as Inland Vessels Act, 1917 has been superseded by Inland Vessels Act, 2021.

(b) The experience gained for the posts of Syring of Lascars and Lascari-I must be obtained on a vessel registered under Merchant Shipping Act, 1958 or Inland Vessel Act, 1917 with a valid 'Certification of Survey'. If the vessel is a fishing vessel, the vessel is to be registered and licensed as per the Marine Fishing Regulation Act, 1979 or under any of the Fishing Regulation Act of States/UTs.

(c) For the post of Fireman, the certificate of having completed pre-sea training course is required to be in a Director General of Shipping (DGS) Circular No. 18 of 2020 dated 24 Apr 2020 and 20 of 2020 dated 27 May 2020. The format for course completion certificate shall be as per that mentioned at DGS Circular 20 of 2020. For certificates awarded prior to 01 Jun 2020, the certificate of having completed pre-sea training course is to be in a DGS Circular/orders issued from time to time for that relevant period. The name and logo of the Maritime Training Institute (MTI) is to be clearly mentioned at the top of the certificate along with the MTI No. and Certificate No. The MTI is required to have been registered and approved by Director General of Shipping during the period the pre-sea training course was undertaken. The candidates are required to submit the following attachments:-

- (a) Attachment 1 - Copy of the pre-sea course completion certificate [Degree/ Diploma/ course certificate]
- (b) Attachment 2 - Copy of the certificate for successful assessment of TAR book/ Cadet record book of the approved shipboard training
- (c) All supporting documents necessary to prove experience and essential qualifications are required to be submitted at the time of filing online application. The same shall be verified at the time of documents verification/ pre-appointment formalities and thereafter Indian Navy reserves the right to issue provisional Offer of Appointment only after vetting, scrutiny of / and completion of verification of all supporting documents with relevant authorities.
